Cancellation policy

In the event of partial or total cancellation of the booked service, the cancelled part will be invoiced on the following basis:

- 25% of the confirmed quote, from the date of confirmation to 30 days before the event.
- 50% of the confirmed quote, from 29 to 21 days before the event.
- 75% of the confirmed quote, from 20 to 8 days before the event.
- 100% of the confirmed quote, from 7 days to the day of the event.

A cancellation is considered partial when the reduction in services exceeds 30% of the services confirmed by the signing of the contract.

Billing

The invoice is drawn up on the basis of the number of packages and participants confirmed at least 48 hours before the event. In the latter period (D-7 to D-1), invoicing will be based on the confirmed offer or, in the event of changes, on the last written exchange. Only the actual number of customers present will be invoiced for single drinks. We therefore ask you to inform us as soon as possible and in writing of any changes in numbers.

On the day of the event, no changes will be made to the planned billing.

Deposit

In some cases, a deposit of 25% calculated on the basis of the initial quote is required, no later than the option date shown on the quote, in order to confirm your reservation.

The Domaine will automatically release the reserved spaces if the customer does not pay the deposit by the requested date. The contract will then be terminated to the exclusive detriment of the customer.

The deposit cannot be reimbursed in the event of total or partial cancellation of the service.

Payment of the invoice

In the case of individual payment by participants, invoices must be settled on site before the customer's departure.

If the invoice is paid by a company or a third party and has been confirmed in writing in advance, we will send the invoice to the address indicated by the customer and open a debit account.

Payment must then be made on receipt of the invoice and within a maximum period of 30 days. If payment is not made by the contractual due date, late payment penalties will be payable from the day following the due date.

Any legal costs incurred by the Domaine to recover its debts shall be borne exclusively by the customer.
